SocEntrep4NGOs

The SocEntrep Erasmus+ co-funded project was launched in November 2021 to address the identified lack of research specifically to determine the challenges and the training needs by current and new social entrepreneurs.

This project's scope seeks to improve the capacity of existing NGOs working within the third sector, current and future social entrepreneurs by providing them with a formal qualification directly related to Social Entrepreneurship. The proposed programme will be designed and developed based on the feedback that the project partners will receive from the participants in the research study to be carried out in this project. The project seeks to achieve the following objectives:-

1. Research current best practices in Social Entrepreneurship (SE) and SE programmes required to support NGOs. This will help in understanding the particular challenges met by current and future social entrepreneurs, employees working in NGOs and NGO volunteers.

2. Design and develop the proposed Social Entrepreneurship programme set for the level recommended by the research and including specialist content also confirmed through the research.

3. Accreditation by the national regulator in Malta, Malta Further & Higher Education Authority (MFHEA) of the new social entrepreneurship online programme. Accreditation ensures that students completing the programme earn a qualification that is recognised within the EU and within those countries that are signatories to the Bologna process.

4. Marketing of the new Social Entrepreneurship programme to recruit suitable social entrepreneurs for participation in the pilot programme Intake #1.

5. Implement the 18-month online Social Entrepreneurship programme as a pilot programme and evaluate its effectiveness. Based on the Erasmus+ funding, circa 60 students will be offered a full scholarship in the programme.



Malta Further and Higher Education Authority

The Malta Further and Higher Education Authority (MFHEA) was officially launched on the 14th September, 2012 and is legislated by the revised Education Act which came into force on the 1st August 2012. Its mission statement is: "to foster the development and achievement of excellence in further and higher education in Malta through research, effective licensing, accreditation, quality assurance and recognition of qualifications established under the Malta Qualifications Framework."

The accredited programme provided by Advenio eAcademy is deemed by MFHEA to be equivalent to the Malta Qualifications Framework under the European Qualifications Framework. This accreditation confirms the quality assurance and recognition of the programme within the EU.

Erasmus+ Programme

The development of the research and the Undergraduate Higher Diploma in Social Entrepreneurship programme together with its implementation of a pilot intake being



developed by the partners is a project that has been approved for co-funded through the Erasmus+ Funding Programme. This project has been approved under Key Action 2 – Strategic Partnership.

The successful application for EU funding enabled Advenio eAcademy to develop significantly. It developed its international network through collaboration agreements for Erasmus+ projects with leading European universities and relevant organisations. This programme will share the core modules of the previously accredited L5 Undergraduate Higher Diploma in SME Management, thus allowing for mixed classes from SME and NGO backgrounds participating in the core modules that will be common for both qualifications. The programme will be structured in THREE different stages.

Stage 1 will include 4 Core modules each with 8 ECTS Credits as outlined above or ARPEL Process for recognition of prior learning and experience would require three to four weeks to complete.

Participation in the programme includes both self-learning and collaborative learning elements. The collaborative elements include weekly online tutorial sessions to provide ample scope for review and discussion of course work with members of Faculty.

Learning outcomes include:

- An advanced level of understanding in the specialised area of prior learning and work experience
- An understanding of entrepreneurial / social entrepreneurial methods and tools in a complex and specialised field of work or study
- An understanding in professional practical knowledge in a specialised

Stage 3: Final Research Project (26 ECTS Credits)

 The Research Project will allow students to hone their analytical and investigative skills by participating in an active research project under a faculty advisor to produce usable data sets, public presentations, and abstracts suitable for publication.

Stage 3: Internship & Embedded Project Report (26 ECTS Credits)

• The Internship Programme provides an opportunity to combine theoretical education with applied work experience.

Have you considered a career in the non-profit or voluntary sector?

To be classified as third sector, an organization should fulfill three conditions:-

"Non-governmental: They cannot be owned or controlled by the state. That said, they will often cooperate with the government, and might receive state funding.

Not-for-profit: While they must have a way of covering their own operational costs (e.g. staff wages, rent, advertising), third-sector companies should put their profits towards the improvement of society, rather than their founders' personal gain.

Socially focused: Third-sector organisations should be driven by a vision of improving the social or environmental landscape. Their focus may include human rights, environmental sustainability or education services, amongst other things".

The European third sector thus accounts for nearly 13 percent of the European workforce. This is a significant contribution because any industry that accounts for 5 percent of the employment of a country is considered to be a major industry....

A second striking characteristic of the European TSE is its engagement of volunteers in addition to paid employees. In fact, over 15 million FTE workers in the civil society sector in Europe are volunteers, which is 55 percent of the workforce".
